AFFIDAVIT OF PROBABLE CAUSE FOR ARREST WARRANT	

Before the Honorable JUDGE Reid Stewart, La Plata County Court Judge:

Deputy Justin Wynne, being duly sworn, upon his oath deposes and says: That he is a Deputy Sheriff employed by the La Plata County Sheriff's Office and has been so employed since July 2018, and is presently assigned to the Patrol Division.

Your Affiant states that he has probable cause to believe that the crimes of:

C.R.S. 18-6-803.5(2)(a) Violation of a Restraining Order as amended a class 2 Misdemeanor

have been committed by **Garrett Mccoy, White/Male DOB: 06/20/1989**. The facts which establish such beliefs are as follows:

On March 12th, 2024, I, Deputy Wynne, was on duty in the county of La Plata, Colorado. At approximately 1628 hours, I went to _____, to serve Garrett Mccoy (DOB: 06/20/1989) with a Temporary Protection Order in case C0342024C 002070. I handed the papers to Mccoy at the door to his residence. Mccoy took the papers and I left his residence. A later review of my body camera footage confirmed that I handed the temporary protection order to Mccoy at 1630 hours. My body camera footage ends when I leave his property at 1632 hours.

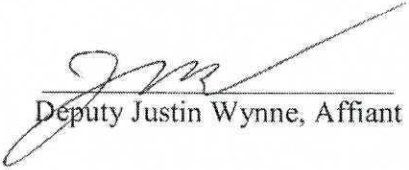
On March 13th, 2024, at approximately 1349 hours, I was dispatched to _____ for a reported violation of restraining order. I contacted the reporting party Kathy Overman (DOB 06/14/1965). She told me the following:

1. Overman is the protected party in a restraining order with Mccoy.
2. At approximately 1632 hours and 1636 hours respectively on March 12th, 2024, Mccoy called her twice.
3. Overman did not answer these phone calls.
4. Overman called today after she learned that the papers had been served before Mccoy made these calls.

I confirmed that Overman is the protected party in C0342024C 002070. The protection order in this case states that Mccoy is to have "No contact except none" with Overman. The protection order was issued March 12th, 2024 and is valid until September 8th, 2024. Overman allowed me to look at her phone, and I confirmed that the two phone calls came from _____, which is the phone number listed in our Insight database as belonging to Mccoy. Overman sent me screenshots of these calls logs.

Based on the time stamp in my body camera footage confirming that Mccoy was in possession of the temporary protection order at 1630 hours on March 12th, 2024, and the call logs confirming he called Overman at 1632 hours and 1636 hours on March 12th, 2024, I believe Mccoy violated the terms of the temporary protection order that had just been served to him.

On or about March 12, 2024, GARRETT MCCOY, who had been personally served with a protection order or had otherwise acquired from the court or law enforcement personnel actual knowledge of the contents of such a protection order, unlawfully and knowingly contacted, harassed, injured, intimidated, molested, threatened, touched, stalked, or sexually abused Kathy Overman, a protected person, a type of conduct prohibited by the protection order; in violation of section 18-6-803.5(1)(a), C.R.S.

All offenses against the peace and dignity of the people of the State of Colorado.

AFFIDAVIT OF PROBABLE CAUSE FOR ARREST WARRANT

I, BRIAN HARRISON, being duly sworn, upon his oath deposes and says: That he is a Deputy Sheriff and is employed by the La Plata County Sheriff's Office and has been so employed since NOVEMBER 2016, and is presently assigned to the Criminal Investigations Unit.

Your Affiant states that he has probable cause to believe that the crime(s) of: CRS 18-3-203(1)(i) Assault in the Second Degree as amended a class 4 Felony, CRS 18-3-302(1) Second Degree Kidnapping as amended a class 4 Felony, and CRS 18-6-800.3 Domestic Violence, have been committed by Garrett McCoy DOB: 6/30/89, White Male, 6'04", 300lbs, Brown Hair, Brown Eyes. The facts which establish such beliefs are as follows:

On 3/19/24 at approximately 1445hrs, Deputy Christensen (LPCSO) responded to a report of a cold disturbance which had occurred at _____ Deputy Christensen spoke with Katherine Overman (DOB 6/14/65) as well as Katherine's sister, _____ and I _____. On 3/20/24 at approximately 1130hrs, Investigator Kyser (LPCSO) and I conducted additional interviews with Katherine,

Based on my involvement with the above interviews, and reviewing Deputy Christensen's report I learned the following:

-Katherine has been in an intimate relationship with Garrett for approximately the last five years, and has been living with Garrett at _____ for approximately the last three years.

-Garrett is a police officer with the Fort Lewis College Police Department.

-Katherine reported that Garrett drinks heavily and has done so for years. Their relationship has been verbally abusive throughout much of the relationship, and Garrett began physically abusing Katherine around June of 2022. Katherine then described a number of domestic violence incidents that had occurred over the following years.

-Katherine described that near the early part of June of 2022, there had been an assault that occurred. Katherine described that she and Garrett had been in their residence, and she had opened a window in the master bedroom and a spring broke, making it so that they couldn't close the window. Garrett was able to close the window, and the following day Katherine opened the window believing it had been fixed. Garrett became upset, and used his arm to sweep Katherine's legs out from under her, causing her to fall and bruise her tailbone. Katherine described that the injury to her tailbone caused her pain for several weeks.

-After this incident Katherine went to Alternative Horizons to seek help, but did not report the incident to law enforcement. Katherine provided Investigator Kyser with a letter from Alternative Horizons stating that she has been a client with them since June of 2022 through March 20th of 2024.

-Katherine also described an incident which had occurred during March of 2023. Katherine explained that it was during spring break. Katherine described that Garrett had taken her cellphone and her keys away from her, and was physically blocking her from leaving both the front and back doors of the residence. Katherine stated that during this incident Garrett had pushed her to the ground, and Katherine was yelling for help, hoping that a neighbor would hear her. When she would begin yelling, Garrett would cover her mouth with his hand, and ultimately caused bruising to her face. Katherine described how in the following days she had to conceal the bruises so that no one would see. Katherine also described that Garrett wouldn't acknowledge what he had done and didn't seem to care that she had visible injuries.

-Katherine also described an incident that had occurred where Garrett had made threats to her. Katherine did not know when specifically this incident had occurred. Katherine told me that she had threatened to call 911, and Garrett had responded that he was 911, and he would hunt her down and kill her if she called. Katherine told me that Garrett is an avid hunter and has access to a large number of firearms. Katherine explained that due to his threats and the fact that he worked in law enforcement she was afraid of reporting the assaults.

-Katherine told me that there were numerous other assaults, and described that after June of 2022 Garrett would assault her nearly every two weeks. Katherine described that during the majority of the assaults he would take her keys and cell phone, and would push her to the ground or into furniture. Katherine described that Garrett was always intoxicated during these incidents, and would regularly drink and hide whiskey throughout the house. Katherine described that when she was able to get away from Garrett she would go to She also began
taking photographs of her injuries which she would send to

her phone and leave the house, and that they would find out that he had killed her.

-As they approached the mudroom, Garrett stopped dragging Katherine and gave her the keys and her cellphone back. Katherine then fled out of the front door and went to

-In addition to the above, Deputy Christensen spoke with Dorothea who advised that there has been several incidents where Katherine has arrived at her house with injuries on her face.

 reported that Katherine has shown up at the house without shoes on multiple times. stated that Katherine has been staying with her for the past several weeks, in addition to large amounts of last June and multiple times over the winter. estimated that Katherine has stayed at her house for her safety over 10 times.

-Through conversations with Karen she also reported that Katherine has contacted her numerous times regarding the assaults. Karen first became aware of the assaults around June of 2023. Katherine would also send photographs of her injuries to Karen, including photographs taken after the assault on 2/5/24.

-Katherine's father John told me that he had first learned about the assaults around Christmas of 2023. John described that Katherine had arrived at his house in Gallup wearing only pajamas with no shoes. John later learned that Katherine had disclosed other assaults to the rest of the family.

-I later reviewed photographs of Katherine's injuries which had been provided by Karen. The following photographs all had timestamps. The dates of the photos are noted below along with descriptions of the photos:

-2/5/24 and 2/6/24: redness and swelling on Katherine's cheek, abrasions on the outside of her upper and lower lips, and the inside of her upper lip is split.

-9/17/23 and 9/21/23: bruise on Katherine's elbow.

-8/6/23: abrasions on what appears to be an abdomen.

-6/16/23: abrasions on Katherine's nose and cheek.

-5/8/23: bruise on what appears to be the side of a breast.

-3/23/23: bruises and abrasions on Katherine's chin, lip, and cheek.

-Karen also provided screenshots of multiple text message conversations. Some of the conversations are between Karen and Katherine, and others are between Katherine and Garrett.

-Of the text conversations that I have reviewed between Katherine and Garrett there are conversations which appear to reference the assault from 2/5/24, as well as assaults around 1/24 and 3/24.

-Katherine told me that during one assault she had threatened to call 911 trying to get Garrett to stop. During the assault Katherine had accidentally dialed and Garrett fled the residence. Katherine told me that eventually she heard knocking on the door, and there was a deputy and SUPD officers outside. Katherine did not make a report to the officers at that time. I learned through LPCSO records that this incident occurred on 6/12/23 and that Deputy Guffey had responded to a report of an open 911 call where Dispatch could hear a female arguing with a male. At that time Katherine had reported that her boyfriend had a drinking problem, but denied that anything else had occurred.

-Katherine told me that a similar assault had occurred around Christmas of 2023. After she was able to get away from Garrett she fled the house in her pajamas and went to her parent's house in Gallup NM.

-Katherine then described the most recent assault which she believed occurred around 2/6/24. (based on additional evidence described below I believe the assault occurred on 2/5/24) Katherine stated that she had been at home sick and was sleeping on the love seat in the living room. Garrett returned home after work around 0900 or 1000hrs. Garrett was intoxicated and angry at Katherine. Shortly after he arrived home, Garrett and Katherine were standing in the living room and Garrett shoved her, causing her to fall to the ground on her side. Garrett then got on top of Katherine. Garrett was on his knees straddling Katherine's body. Garrett then placed his arm around her neck from behind and was squeezing her neck. While he was doing so he was telling Katherine that he would break her neck and kill her.

-At some point Katherine was able to turn onto her back and began screaming for help. Garrett then covered her nose and mouth with his hand. Katherine stated that Garrett has large hands and was covering her nose and mouth in a way that was keeping her from breathing. When Garrett would move his hand she would begin screaming again, and he would again cover her nose and mouth. This occurred between two and four times. Katherine described that while Garrett was covering her nose and mouth she was beginning to feel lightheaded and described that her head was "tingling". Garrett was also pressing Katherine's head into the floor. As this was occurring Katherine received injuries to her face and mouth, describing that she had a split and swollen upper lip. Her nose also began bleeding. Katherine described that she could smell alcohol on Garrett, and that he was sweating and the sweat was dripping off of him onto her face.

-After Katherine's nose began bleeding, Garrett got off of her and went to the kitchen. He then returned with a towel, and began cleaning up Katherine's face. Garrett also began stroking her hair. Katherine was still on the floor at this time.

-Garrett then grabbed Katherine's right leg using both of his hands, and began dragging her through the living room, through the kitchen, and towards the entryway to the mudroom and back door. As he was doing so, he began threatening Katherine, telling her that he was going to take her out to La Boca Canyon and kill her.

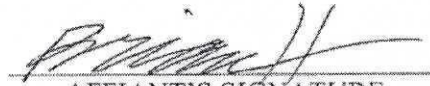
-At some point during the assault Garrett had taken Katherine's keys and cellphone from her. Katherine began pleading with Garrett, telling him that he can't do this. Katherine also told Garrett that her friends would be checking on her and would go looking for her if she didn't have

-Of the text conversations that I have reviewed between Katherine and Karen there are conversations which reference the assault from 2/5/24, as well as assaults around 3/23, 6/23, 10/23, and 12/23.

-There are numerous additional text conversations, voicemails, and other photographs that Karen provided which have not yet been reviewed.

Based on the above, I have probable cause to believe that on or about 2/5/24, Garrett McCoy, committed the crime of assault in the second degree, a class 4 felony, and second degree kidnapping, a class 4 felony. Additionally both crimes are acts of domestic violence, and there is evidence to believe that numerous similar events have occurred since approximately June of 2022.

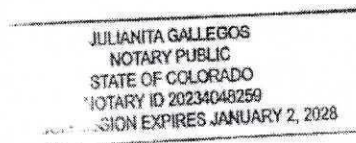
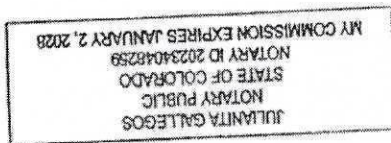
