Narrative

This incident happened in the State of Colorado and the County of La Plata.

On 06-12-2023, at about 1401 hours, I Deputy Mitch Guffey, was dispatched to 24 Artemisa Ct for a disturbance. I was told that an unknown female called the 911 emergency line. Dispatch told me that they heard a female yelling "Get away from me". I was also told that it appeared like she was arguing with a male. Dispatch could hear screaming and cussing coming from the female and that the argument was over alcohol. I requested that Southern Ute respond to the address due to an extended eta. The phone disconnected while dispatch was on the line with the female. They attempted contact back but it went to voicemail. The voicemail belonged to "Katy".

Upon arrival I saw Southern Ute at the door. They were attempting to knock on the door. I walked up to the front door, and a female opened the door. She was crying and appeared distraught. She only opened the door enough to speak to us. She told us that we could leave and were not needed at the house. She refused to answer most questions but I managed to learn the following information; "Katy" and her boyfriend are not married but are considered common law. They have been together for about 6-7 years. She refused to give me his name but told denied any allegations about domestic violence. Katy told me that he has a drinking problem and that was what the argument was about.

I ran a New Mexico plate while on scene and was able to identify the female as Katherine Overman [REDACTED] I went across the street to a neighbor's house since I saw her playing with her kids outside. I asked her about 24 Artemisa Ct. She told me that the man that lives at the house drives a jeep and works for the Fort Lewis College Police Department. She told me that he left in his vehicle before we arrived. She also told me that she can hear them yelling at each other a lot.

I contacted the campus police department with Deputy Tipton and learned that the male was Garrett McCoy [REDACTED] Through a QDA search with dispatch, I was able to find a 1999 white jeep that was registered to him and at 24 Artemisa ct. I was also given Garrett's phone number from the campus police. I called twice and left a message. Deputy Tipton also attempted contact via phone. I reached out to the Campus Police and asked them to reach out since we were unable to contact him.

Bodycam will be added into Watchguard.
