Exhibit C — Special Provisions

This Exhibit C and each Special Provision below is incorporated into and made part of the Agreement to which they are appended, as if fully set forth therein.

C1. Renewal

Subject to continued availability and appropriation of public funds for payment of the County's obligations under this Agreement, this Agreement may be renewed for two additional one-year terms upon written notice from the County. The bid prices, including any annual adjustments as stated herein, shall remain in effect for this and subsequent terms. Renewal shall be contingent on additional funding being appropriated, budgeted, and otherwise made available for such purposes, subject to the County's satisfaction with the Services received during each preceding term.

C2. Minimum Insurance Coverage Requirements

a. Commercial General Liability

\$1,000,000 / occurrence

b. Automobile Liability

\$1,000,000 / occurrence

C3. County as Additional Insured on Commercial General Liability and Automobile Liability Policies

Respecting the Commercial General Liability and Automobile Liability Policies Durango Dance is required to obtain under this Agreement, Durango Dance shall name as Additional Insureds both La Plata County and the La Plata County Board of County Commissioners.

C4. Subrogation Waiver

The following insurance policies required of Durango Dance under this Agreement shall include clauses stating that each carrier shall waive all rights of recovery, under subrogation or otherwise, against the County:

C5. Additional Persons Authorized to Audit

In addition to the County and any of its duly authorized representatives Durango Dance shall permit the following public or private entities or persons to conduct the discretionary audit described in paragraph 12 of this Agreement:
